





Philip Arnold is a partner with Bickerstaff Heath Delgado Acosta LLP in Austin, Texas. He counsels Texas counties and municipalities in a variety of local governmental issues, including eminent domain litigation; real estate transactional and title issues; administrative law; water law; Section 1983 Civil Rights defense; and drafting Interlocal Agreements, Tax Rebate Zones (TRZs) and Economic Development Agreements.

Robert Bass is a Hale County native. Licensed to practice law after graduation from Baylor Law School in 1976, served as an assistant District Attorney in Tarrant County before serving a term as County Attorney in Hale County. Joined Jim Allison in 1990, became partner in the firm today known as Allison, Bass & Magee, LLP in 1997. Areas of practice include road disputes, subdivision regulation, tax abatement, voting rights and litigation. Married to Robin Bass in 1979, have three grown children. Dr. Busch's innovative teaching is evidenced by his incorporation of the StrengthsFinder program into his courses and executive education teaching. This is a program that provides executives, students, and staff with the opportunity to discover their natural talents and to gain insights into the development and utilization of those talents. Additionally, Dr. Busch is a recipient of the 2008 Mays Faculty Fellowship for Teaching Innovation for his significant contributions and innovations to the teaching/learn.

Greg Brinkmeyer is an instructor for the Texas Engineering Extension Service (TEEX). When not teaching, he is the manager of a traffic engineering consulting firm specializing in providing expert witness services throughout Texas with an emphasis on work zone temporary traffic control. 
