



A CPA is challenged in today's work world to serve not only his/her client or employer, but also to protect the public interest by ensuring transparency in financial reporting and fair administration of the tax laws. In balancing the two interests, a CPA may face an ethical dilemma. This course covers not only basic ethical frameworks, but also specific rules governing CPA practice and responsibilities. It concludes with a section on how a CPA can put ethics into action.

  - » CPAs employed in industry who provide internal accounting and auditing services.
