- ▶ Treasury as of this morning has not issued requirements for ARPA Close Out
- ▶ Close Out by December 31, 2026
- ▶ Once a specific project is completed, start reviewing the files to ensure you everything you need.
- ▶ Check obligations and expenditures and reconcile to the grant awards
- ▶ Document! Document! Document!
- ▶ Mirror Your Own Prior Grant Processes
